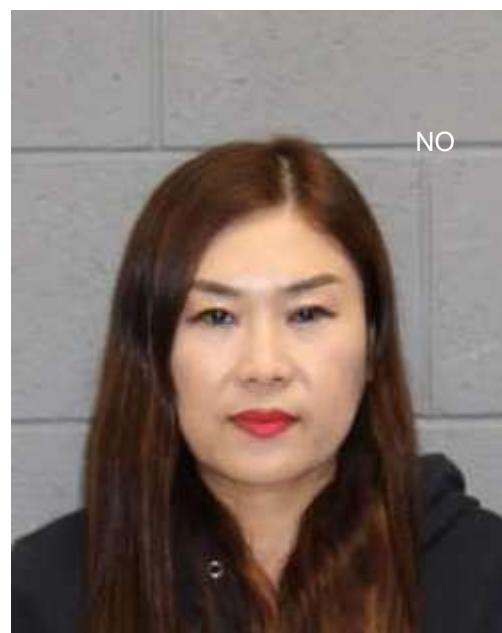

On the afternoon of October 23, 2019 Naugatuck Detectives executed a search-and-seizure warrant at the Maple Massage- 1177 New Haven Road, Naugatuck, CT. The search warrant stemmed from an investigation that was initiated after this department developed information that patrons were paying for sex acts at the business. During the lengthy investigation which was led by Naugatuck Detective Thomas McGarvey, evidence was gathered that employees would accept cash in exchange for sexual acts. As a result of the search warrant, Naugatuck Police took the listed persons into custody for the aforementioned charges. The accused were held on bond pending their appearance at Waterbury Superior Court on October 24, 2019.
